# LOCATION OF OTHER CLINICS AND TEST SITES SCHEDULED FOR YOUR VISIT TO THE SJOGREN'S CENTER

#### OPHTHALMOLOGY

If you have an Ophthalmology visit scheduled after your appointment...

The Ophthalmology clinic is located just down the hall from the Sjogren's (Rheumatology) Clinic, in bay #3.

### IMAGING (Ultrasound, X-rays, CT scans)

If you have an imaging test scheduled after your appointment...

As you exit the Rheumatology Clinic, make a right and proceed down the hallway. Make another right just before the guard station. Follow the hallway as it makes a 90-degree left turn and then a 90-degree right turn until you get to the red elevators (just before the entrance to the Bayview Cafeteria). Take the elevators up to the First Floor. Please note that the ground floor is 01. Make a left off the elevator and report to the Imaging Desk for registration.

### **BLOOD TESTING**

If you were given an order for blood work and you are not restricted by insurance, you can have your blood drawn at one of two sites:

1. Bayview Medical Office Building:

As you exit the Rheumatology Clinic, make a right and proceed down the hallway. Make another right just before the guard station. Follow the hallway until you reach the blue elevators. The Outpatient Blood Lab is directly across from the blue elevators on the right.


2. 301 Building

As you exit the Rheumatology Clinic, make a right and proceed all the way down the hallway past the guard station. Exit the BMO Building via the blue awning entrance. Cross the street and then make a left. Walk to the 301 Building on the next block. Enter via the rear (parking lot) entrance. Sign in with the security guard and take the elevator to the 3rd floor. Report to the Satellite Outpatient Blood Lab.

## NEUROLOGY TESTING (EMG, skin biopsies for neuropathy) OR NEUROLOGIST APPOINTMENT

If you have a Neurology Test (EMG, skin biopsies for neuropathy) or Neurologist visit scheduled after your appointment....

As you exit the Rheumatology Clinic, make a right and proceed all the way down the hallway past the guard station. Exit the BMO Building via the blue awning entrance. Cross the street and then make a left. Walk to the 301 Building on the next block. Enter via the rear (parking lot) entrance. Sign in with the security guard and then proceed to the Neurology Clinic straight ahead and to the right.



**OTOLARYNGOLOGY (to see Dr. Jean Kim for lip biopsy at White Marsh)** (4924 Campbell Blvd, Nottingham, MD 21236).

Take Bayview Blvd going north as shown in map below. Go straight at the traffic light (crossing Lombard Street) and merge onto I-895-North

Continue on I-895. It will merge onto I-95 North. Continue on I-95 N to White Marsh. Take exit 67 from I-95 N (8.5 mi)

Continue on White Marsh Blvd to Honeygo Blvd. Take a left on Honeygo Blvd and then a left on Campbell Blvd. Take the next left and head straight to the parking lot for the **Johns Hopkins Health Care & Surgery Center - White Marsh. Proceed to Suite 210 in the 4924 Building**
